## **House Passes Broadcast Decency Enforcement Act**

Washington - Mar 11, 2004 - The House of Representatives approved the Broadcast Decency Enforcement Act of 2004 by a vote of 391 to 22. This act, which modifies the Communications Act of 1934, increase the maximum fine for radio and TV indecency. The bill would raise the maximum fine for a broadcast license holder from \$27,500 to \$500,000. The fine for a performer would also increase from \$11,000 to \$500,000.

Decency has been a hot topic in the news lately, and opponents of the legislation feel that this action undermines free-speech rights. Clear Channel has already announced it will require its air talent to pay part of any indecency fines. AFTRA has opposed the Clear Channel move saying that the station licensees are responsible and that performers are following owners' mandates.

The Senate has a bill that will also raise fines to \$500,000. On March 9, the Senate Commerce Committee unanimously passed a bill to increase fines for broadcast indecency violations. The measure is listed as S. 2056. The Senate bill includes wording to direct the FCC to conduct a mandatory license revocation hearing after three indecency violations.

The House bill is listed as H.R. 3717.

Ireland (relayed by the BBC) is no longer broadcasting. The BBC itself has reduced its programs to North America, although it can be monitored on transmissions aimed at other areas.

## New NM For Ohio Slow Net

Henry Koenig, WD8Q, of Mansfield, has been named Net Manager (NM) of the Ohio Slow Net (OSN) effective April 15. He succeeds Ken Buser, WB8KQJ, of Hinckley, who retired after 10 years of managing this net. The announcement was made by Ohio Section Manager Joe Phillips, K8QOE.

The OSN, Ohio's longest continuing traffic net, currently passes traffic in CW at 3.708 MHz each day beginning at 6:10 p.m. (1810 local time; 2310 Zulu).

"Ken's leadership was outstanding in continuing this net in times difficult for a CW traffic net," said SM Phillips, "the Ohio Section thanks him for his excellent service."

New NM Koenig, a ham radio operator for 24 years, has served his local club, IRAC of Mansfield, in several capacities including President. His first OSN experience was January 2003 but quickly became a regular member and currently holds the Net Control Station slot on Tuesdays. He is active on the Buckeye nets and 8th Regional Net (8RN) and on phone, Ohio Single Side Band Net (OSSBN). Henry's appointment to be NM was recommended by Ken. "There are more popular ham radio activities than a CW traffic net," said SM Phillips, "but this does not diminish the dedication and value to public service the OSN under Ken Buser and now Henry Koenig serves amateur radio. These amateurs contribute greatly to the strength of the Ohio Section."
