TMRA By-Laws Review Committee Report

The TMRA By-Laws Committee met recently to review the comments that members had made concerning the proposed changes to the By-Laws - a copy of the revised, proposed changes is included elsewhere in this issue of the Newsletter.

One of the main issues raised by several members addressed the question of how many signatures should be on the TMRA checking account, and who should they be: the Committee's revised recommendation is that there should be three and these 3 would be the Treasurer, the President, and the Secretary.

Another issue raised concerned membership cards: as the members appear to be divided – some members do not see a need to have a card, some do, the Committee decided to leave the revision in the proposed changes to make it an option. "yes" and "no" boxes will be on the membership application forms so that members can make their choice known to the Membership chairperson.

On the issue of the Membership chairperson, the change proposed was that that would be a position appointed by the President, to be filled by someone willing to take the position. The committee saw an advantage in having year-to-year continuity in that position, and the previous By-Law, stating that it would be part of the duties of the Vice-President. could lead to frequent changes of personnel and could be a deterrent to some who might otherwise be willing to run for the office of VP. The committee has not revised that proposed change.

One issue that the previous By-Laws and the proposed changes did not address is how we would conduct elections in the event of more that two candidates for an office, and how we would handle tie votes. Robert's Rules of Order gives several examples of how these could be handled: the committee is proposing the procedure as outlined in the revised changes -see under Section IX. Nomination and Election.

In Article VII, the insertion of "un-budgeted" was proposed to make it possible for the club to offer prizes at the HamFest, to offer scholarships

at UT and Owens Tech, and to offer prizes at the Science Fair at UT – these are all budgeted items. As the Articles stand at present, they do not allow for any of the TMRA's money or assets to be used for the benefit of club members or other private individuals. The present word "insure" in the Article apparently was an inadvertent change, some time in the past, from "inure" – no-one is sure why, but possibly the result of a computer spell-checker? – the committee has corrected it back to "inure".

As Chair of the By-Laws review committee, I want to thank those TMRA members who gave us input into our review, and thank the committee members for their time; the review was not done lightly and we spent many hours over several evenings on it. The proposed By-Law changes will be presented also at the January TMRA meeting for review and discussion by the membership present, and hopefully we can vote on the changes.

Advanced Weather Spotter Training 2005

Indiana-Michigan-Ohio Skywarn and the National Weather Service of Northern Indiana are announcing an upcoming Skywarn training session. It is titled 'Advanced Weather Spotter Training 2005.' Three speakers are slated: Dr. Bart Wolf is an associate professor of meteorology at Valaparaiso University. The second speaker is Roger Edwards, a meteorologist from the Storm Prediction Center in Norman, Oklahoma. Mr. Edwards is also a storm chaser and will give a presentation entitled, 'Chase Forecasting.' In addition, Mr. Steve Eddy is to present, 'Radar 101--Learn the Basics.'

This program is scheduled for Saturday, March 12, 2005 beginning at 8 a.m. This all day seminar will be held in Elkhart, Indiana. A fee of \$25 is required before February 15th. After that date the fee is increased to \$30.

This registration fee includes not only the lectures but coffee, other beverages, rolls, donuts in the morning, a lunch (1/2 chicken, mashed potato and green beans), and snacks and beverages at an afternoon break period. At the end of the presentation door prizes will be awarded.

Next site is http://members.fortunecity.com/xe1bef/hf-antennas.htm Here is offered a gigantic clearinghouse of construction and theory articles on every conceivable antenna from 160 through 2 meters.

My final offering is http://w4zt.com/ This site has a large list of links on antennas, powerpole connectors, license upgrading and protection from lightning strikes.

Try them out and you may find some new avenues to explore in our hobby.

Skywarn Recognition Day

On December 3rd and 4th, 2004, the 5th annual SKYWARN Recognition Day is planned. This operating event is organized by the National Weather Service and the American Radio Relay League. This operation celebrates the contributions that volunteer SKYWARN radio operators make to the National Weather Service. This event will originate from NWS offices all over the United States. SKYWARN operators will transmit on 2, 10, 15, 20, 40 and 80 meter phone and CW, on PSK-31 and 2 meter APRS mode. It is expected that nearly 80 different NWS offices will be represented on the air. Operations begin at 7 p.m. EST on December 3rd and conclude 24 hours later.

More specific information can be found in the ARRL publication, QST, or at http://hamradio.noaa.gov. Participants can qualify for a certificate and some individual sites will be issuing QSL cards.
