The FCC has directed the City of Manassas, Virginia and its BPL system operator COMTek to take measurements to make sure its system complies with FCC Part 15 rules. This action was taken due to a complaint lodged by an ARRL member who had filed a complaint for alleged BPL interference.

Attorney Nick Pittner WB8TMF has been appointed Ohio Section State Government Liaison (SGL). He will be monitoring proposed legislation that effects amateur radio in Ohio and will advance ideas that will promote ham radio wherever possible.

Congresswoman Marcy Kapturs office is waiting for the quarterly report from the FCC on BPL due out soon. Her office will then determine which direction on the issue they will take. I urge all licensed members to write to Representative Kapturs office, urging her to co-sponsor House Resolution 230. Make up your own letter and /or use the form letter at www.arrl.org . Please send a copy to myself and I will forward it to the proper people.
