Morse code is no longer required for any Amateur license. Text books are \$25 (available on 1st day) - ARRL *Ham Radio License Manual* 2nd Ed. The test is \$15 due at time of test on the second day.

TRMA does not charge for the class.

An Emergency Paging Method

Should an emergency occur where Ham radio operators need to be notified of an impending disaster or a request to assist with an occurring disaster, a page can be sent out using the Cellular phone grid and the internet. There are several different types of emergency paging systems and I have tried almost all of them. Currently, our local government uses this method and it is effective and easy.

*"But wait!!! If there is a disaster... those phones/internet may not work!" *

Most disaster warnings are telegraphed far in advance such as a tornado watch or severe storm warning. At this point many hams are monitoring frequencies and listening for news. Local disasters that happen without warning such as a nuclear power plant evacuation or aircraft down are likely the ones where a quick call up is needed. These disasters do not necessarily take out the entire phone/internet system.

"I don't have a phone or I do not want to receive texts". There are test messages sent once a week. These tests are to make sure you are receiving the sent texts. There are fewer individuals today that do not have a mobile phone at their disposal. Any phone that can receive texts can be used to receive the page. No cell phone, no texts.

When a page is sent it will likely tell you to tune to and monitor your local ham radio emcomm frequency. There, hams could get the details they need for responding.

How does this work? A text message is sent to your phone's e-mail address. It would consist of your phone number followed by the provider's @ domain.com. Most carriers charge for this. It is only free when you have signed up to receive text messaging through your phone carrier.

"Who would send out the pages?" Any station that has the list could store it in an e-mail account with a "groups" setting such as what Gmail provides or you could create a list and have your local EMA send the pages.

Most operators carry their phone with them and it is a great way to advise the Ham radio community of anything that might be of importance. Best of all, you are not signing up to an agency such as twitter or facebook.
